The Prices Board, having considered it expedient in the public interest to control the prices of goods and services, makes the following Special Price Order pursuant to section 56 of the Fair Trading Act 1998.

ORDER

1. Short title and commencement – (1) This Order may be cited as the Special Price Order (No. 1) 2012 (“the Order”).

(2) The Order comes into effect on the 1 May 2012.

2. Maximum prices – (1) The maximum ex-factory, wholesale and retail prices for the goods specified under Column 1 of Schedule 1 shall be the prices specified under Columns 2, 3, 4, 5 and 6.

(2) Where the goods specified under Column 1 in Schedule 1 is specified by reference to a specific measure, the maximum ex-factory, wholesale and retail price at which those goods may be sold shall be adjusted proportionately on any greater or smaller measure.

(3) The maximum ex-factory, wholesale and retail prices specified in Schedule 1 is inclusive of the Value Added Goods and Services Tax.

3. Order to be prominently displayed – Copies of the Order shall be prominently displayed on all premises where the goods specified in Schedule 1 is sold or offered for sale.

4. Changes in measure or composition – No trader shall sell or offer for sale the following goods:

- (a) any packet of Pall Mall filter and Pall Mall menthol cigarettes; and
 - (b) any pouch of roll your own tobacco,
- at a measure that is different to the measure specified in Schedule 1

5. Trader to issue receipt – A trader shall on demand, issue the purchaser with a receipt, setting out:

- (a) the name of trading place and date of sale;
- (b) the quantity of goods sold;
- (c) the price paid for the goods sold; and
- (d) the nature of the transaction as either wholesale or retail sale.

6. Revocation – Prices for the locally manufactured beer, cigarette and tobacco in Schedule 2 of the General Price Order (No.2) 2012 which commenced on 18 April 2012 is hereby revoked.
