PUBLIC NOTICE

Cancellation of Foreign Investment Certificates (FICs)

Notice is hereby given for the following Foreign Investment Enterprise (FIEs) that have been issued with Foreign Investment Certificates (FIC) but failed to notify the Ministry on status of business operations.

Your FIC will be subject to cancellation pursuant to Section 12 [1] (e), (f) & (j) of the Foreign Investment Act 2000 ('Act') stipulating that:

"A certificate issued under this Act may be canceled by the Chief Executive Officer if the business has not commenced operations within 2 years from the date the certificate was issued or the business has ceased operations in Samoa or the holder of the certificate becomes a Samoan citizen".

As per Section 12[2](b) of the Act it requires *'the certificate holder to make written submission within ten (10) working days from the date of receipt of the notice'* advising the Ministry on the reason for not notifying the Ministry on the status of business operations. Your failure to do so may result in your FIC being cancelled under the Act.
