

ATTENTION BUSINESSES

Are the businesses you deal with treating you fairly?

If a business you deal with tries to restrict how you operate in a way that is anti-competitive, they may be breaking the law.

A business might break the law if it places conditions on you that:

- *Prevent you from buying goods or services from other businesses;*
- *Prevent you from selling goods or services to other businesses;*
- *Restrict the way you sell things, including by requiring that you do not discount or re-sell things for less than a certain price;*
- *Prevent you from dealing with certain customers; or*
- *Prevent you from re-selling the things you purchased from them in certain places.*

If a business you deal with makes you agree to conditions like these, they may be breaking the law.

If the Competition and Consumer Act 2016 is breached, this is punishable by fines for individuals and companies.

POWERFUL BUSINESSES MUST NOT ABUSE THEIR POWER

Large businesses, or businesses without many competitors, can be very **powerful** in a market – they might be able to choose who they deal with, and control the terms and conditions.

Having substantial market power is not unlawful, but abusing this market power may breach the **Competition and Consumer Act 2016**.

If a powerful business behaves in a way that:

- *Leads to one or more of its competitors going out of business;*
- *Prevents new businesses from starting up, for example by refusing to supply them with things they need to do business; or*
- *Prevents a business from competing in another market, for example if the powerful business makes its customers agree not to deal with the other business;*

This might breach the Competition and Consumer Act 2016, if the behaviour damages competition in the market.

It is **not unlawful to compete** – all honest businesses try to beat their competitors by offering cheaper prices or better goods.

If a very powerful business uses its position to damage competition, this may breach the law and is **punishable by fines**.
